### **Let Only Service**

At Homelink Property, our LET ONLY service is designed to help you find and secure the right tenant for your property. We start by advising you on the likely rental income and then market your property online. We arrange viewings between you and prospective tenants (unaccompanied by our agents) and handle negotiations on offers, keeping you informed every step of the way. We conduct thorough background checks and collect holding deposits, the first month's rent, and the tenant's deposit. We also prepare the necessary tenancy agreements and, if provided with your bank details, set up a standing order for rent payments.

#### **Let Only Plus Service**

The LET ONLY PLUS service from Homelink Property includes everything offered in our standard LET ONLY service, with the added benefit of accompanied viewings. If your property is currently occupied, we ensure that the existing tenants are given appropriate and lawful notice before any viewings. Additionally, we handle negotiations, collect holding deposits from prospective tenants, and keep you informed about all offers until the tenancy agreement is signed.

Both LET ONLY and LET ONLY PLUS are aimed at experienced, compliant and qualified Landlords who manage their own portfolio of properties, who can confirm that they are fully compliant with current legislation (landlords will need to sign our disclaimer to confirm that Homelink Property will not be held liable for any breaches of any Acts pertaining to letting out your home).

## **Rent Collect Service**

The Rent Collect service from Homelink Property includes advising on, demanding, and accounting for rent throughout the duration of the tenancy, including any extensions or renewals. We handle all rent collection efforts, including sending formal demands, contacting tenants by phone or in writing, and arranging payment. If the tenant has a guarantor as part of their tenancy agreement, we will also pursue payment from the guarantor if the tenant fails to pay the rent.

#### **Fully Managed Service**

The Full Management service from Homelink Property offers comprehensive management of your property, building on our Rent Collection service. We handle all tenant inquiries, arrange mandatory safety inspections for gas and electricity at your expense, and conduct periodic property visits, providing you with detailed condition reports. We manage any necessary repairs, servicing, or maintenance to keep your property in good condition and compliant with legal requirements. At the end of the tenancy, we perform a check-out inspection, take meter readings, and provide a re-letting report to assist with re-marketing your property.
