| Holding deposit | One week's rent |

| Rent | Subject to agreement |
| Security deposit | 5 weeks rent |
| Material change of tenancy | £75+VAT (plus £25+VAT per additional change) |
| Early release | Landlords cost of remarketing and setting up of new tenancy. Rent must be paid until a new tenant is found. |
| Late payment of rent | Interest of 3% above the Bank of England base rate on balance due each day |
| Key replacement | Dependant on type of lock and key required |
